
4. No person shall be appointed as a Trustee or continue to be such trustee unless he or she is financially, physically mentally or morally fit.

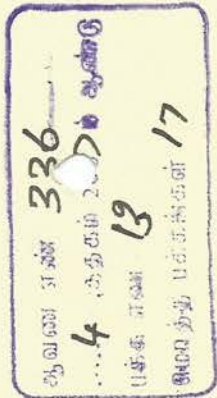

8. The board of trustees shall have the power to receive contributions in cash or in kind either for the above said general purpose or for any specific and shall deal with the same.
9. The Board shall have complete control over all affairs of the Trust including the power to collect any fee or charges of all description and nature. The Board shall also assume all those powers which are necessary and required for purposes of preservation of the Trust, the Trust properties and of the title of the Trust of the Trust properties.
